ESSA includes a wide array of **grant** programs that are designed to help to ensure success for students and schools. Funded programs provide schools and districts with resources focused on meeting the needs of students, parents and families, teachers, and school leaders.

Funds are shared equitably with private schools within our geographic catchment.

## Title II, Part A

Supporting Effective Instruction





*This program is designed to advance excellence in teaching and learning and to promote equity in educational opportunity for all students. . .*

*through professional development opportunities for all educators including leaders, teachers and teaching assistants.*

Under ESSA, the Title II, Part A provides funds for the purposes of:

- Increasing student achievement consistent with NYS academic standards;
- Improving the quality and effectiveness of teachers, principals, and other school leaders;
- Increasing the number of teachers, principals and other school leaders who are effective in improving student academic achievement in schools; and
- Providing low-income and minority students greater access to effective teachers, principals, and other school leaders.

# Herricks Title II ESSA Funded Programs

*Collaborative work to align curriculum and instruction including curriculum writing, turn-key training, and professional learning*

*Assist teachers and school leaders to cultivate a cohesive classroom environment and promote positive school climate through Responsive Classroom approaches*

*Training to implement the districtwide Response to Intervention/Multi Tiered System of Supports (RTI/MTSS) plan*

*Instructional coaching and training on developing high-quality learning targets and using engagement protocols to enhance instruction*

# 3

## Title III, Part A

English Language Learners and Immigrant Students



*Helps ensure that English learners, including immigrant children and youth, attain English proficiency and develop high levels of academic achievement.*

Herricks has a maintained steady ELL population over many years. Our ENL program for ELLs is both standalone and integrated. The standalone program is delivered as either pull-out or push-in. The integrated component is delivered both through co-teaching and dually certified teachers.

# Herricks Title III ESSA Funded Programs

*Consultants and conferences for teachers of English as a New Language (ENL) and Teaching English to Speakers of Other Languages (TESOL)*

*Continue the purchase of library books for ELLs in their native language or at lower Lexile levels*

*Summer ENL Jumpstart Program and ENL Writing Enrichment Program to maintain exposure to English language and American culture*

*Translation and interpretation services to strengthen home-school communication, including letters and forms for college for families of high school ELLs.*

## Title IV, Part A

Student Support



*This program provides supplemental funding to help provide students with access to well-rounded educational opportunities, learning conditions that cultivate a safe and healthy environment, and improve the use of technology.*

# Herricks IV ESSA Funded Programs

*Second Step Program at elementary and middle schools for bullying prevention*

*Professional books on culturally responsive teaching*

*Consultants, including those through our Northwell affiliation, to work with school-related mental health providers and counselors and/or to work directly with students on social emotional learning and resilience*

*Training/Participation in programs that promote positive school climate such as Challenge Day*

*Programs that prevent the use of alcohol, tobacco, cannabis, and e-cigarettes*

## Title V, Part B

Rural Education Achievement Program (REAP)



*This program provides additional resources to assist rural districts in meeting state definitions for the New York State Accountability System.*

- Release of grant allocations (June)
- Meeting w/constituents and stakeholders (June)
- Deadline for submission of application (August 30)
- Approval and release of funds (November/December)
