II Executive Session

Mrs. Chin moved that the Board of Education recess into Executive Session to discuss contract negotiations and personnel matters. The motion was seconded by Mr. Zanetti and passed by unanimous vote.

III Board Meets with High School Students - 6:30PM

The members of the Board of Education, Dr. Celano, Ms. Guercin, Ms. Maggiacomo, Ms. Keegan, Principal, and Mr. Hodge, Assistant Principal, met with the High School Student Government for the annual Board of Education – Student "Fireside Chat".

The student government president introduced herself and stated that on behalf of the Student Government and all Herricks students, she would like to thank the Board of Education and Central Administration for all the upgrades that have been done in the High School. She added that the Students and the Herricks Community appreciate the Board's support.

The student government president stated that the meeting will run under a minor change from last year's format. Tonight's format is as follows:

Students will get 3 minutes to speak Board will get 1½ minutes to respond Students will get 1 minute to rebuttal

The students introduced themselves as they spoke. Some of the topics brought up by the

students and discussed included the following:

- Wi-Fi in High School
- Mental Health
- Improvements to Auditorium
- Condition of Bathrooms in the Locker Rooms

Members of the Board and Administration discussed these topics with the students. In conclusion, the students thanked the Board and Administrators for coming to the *Fireside Chat* and added that they value the Board of Education's voice.

Dr. Celano thanked the Student Government Executive Board for a well-organized *Fireside Chat*. He added that the *Fireside Chat* is a unique tradition. Dr. Celano then stated, the Board and Administration enjoy meeting just as much as the students do. The topics the students presented were very meaningful. Great job!

On behalf of the Board and the Administrators, Mrs. Chin thanked the students for meeting with them. She added that the Board and Central Administration love the "Fireside Chat".

The meeting with the students ended at 7:18pm.

At 7:41pm, following the meeting with the High School Students, the Board moved into High School Cafeteria "B" to continue with the Regular Board Agenda.

IV Meeting Reconvened - 7:30PM

The Regular Meeting of the Board of Education was reconvened at 7:41pm. There were 2 government representatives present.

VI Announcements and Correspondence

Mrs. Chin welcomed students, parents and the public to tonight's Board of Education meeting. Mrs. Chin then opened the meeting to announcements and correspondence from the Board. Among the items raised were the following:

The Student Government Representatives thanked the Board and Central Administration for meeting with the students at the annual *Fireside Chat*. The students added that they appreciate all that the Board of Education does for the District and felt that this year's *Fireside Chat* was one of the best. It was well-organized and enjoyable.

The Student Government Representatives stated that they are looking forward to the first annual *Winterball*, which will be held this Saturday, February 1, 2020. The dance is open to grades 9th through 12th and added that they are hoping for a large turnout.

Mrs. Chin thanked the Student Government Representatives for attending the *Fireside Chat* and added that the Board always enjoys this event. Mrs. Chin stated that she wants the students to know that they do not have to wait for the *Fireside Chat* to speak to the

Board; they can come to the Board at any time with their questions and concerns.

Ms. Maggiacomo stated that she is looking forward to the Middle School Production, *Seussical*, which will be performed this Friday, Saturday and Sunday. She added that she was fortunate to see the students in their costumes during dress rehearsal.

Ms. Guercin stated that she attended a SEPTA presentation on Literacy. The speaker was Dr. Mike Imondi, Director of ELA, Reading, and Library. She added that this presentation was not just for special needs students, but for all students. Dr. Imondi spoke about the Herricks Literacy program and instructional support offered inside and outside of the classroom, which is available to all students. Ms. Guercin stated that it was a very informative and well-attended presentation.

Ms. Rutkoske stated that the Office of the State Comptroller released the fiscal stress monitoring scores for school districts and added that she is happy to say that Herricks received a fiscal score of "No Designation", which means Herricks is in good standing. Ms. Rutkoske was also happy to state that Herricks will be receiving a little over 7.50% increase in State Aid. She added there will be more to follow as we start our first of four presentations on the 2020-2021 Budget at the end of February.

Mr. Gounaris stated that he attended the Wellness Fair at Denton Avenue School this week. He added that it was very informative and well-attended.

Mr. Gounaris was happy to state that he was proud to be part of the *Fireside Chat* with the High School students. It is so important that they voice their concerns to the Board of Education. The students help the Board to reinforce and work on areas that were discussed.

Mr. Hassan stated that he too enjoyed the *Fireside Chat* and added that the Board will find the funding to tackle some of the requests, but asked the students for patience. Mr. Hassan then stated it was a great meeting, and the Board appreciates the students' honesty and the way they presented their concerns.

Mr. Zanetti stated that he enjoyed the *Fireside Chat* and added that the students gave good feedback and spoke with eloquence.

Mrs. Chin stated that she echoes the Board's statements regarding the *Fireside Chat*. She then stated that seeing the students throughout various events validates all that the Board does. Mrs. Chin added that she is always impressed with the students' demeanor and so proud of them. Mrs. Chin then stated that as a District you can see how far we have come and how far we can go!

Dr. Celano thanked the Student Government Executive Board for another well-organized *Fireside Chat*. He added that we continue to stress our commitment to our students and we are always delighted to hear the students' thoughts. The District prioritizes what improvements are needed and the students help us in identifying what is important.

Dr. Celano stated that we are looking forward to the Middle School Musical, *Seussical*, which will be performed at the Community Center Auditorium this weekend.

Performances will be on Friday and Saturday at 7:00pm and Sunday at noon.

Dr. Celano then stated that Center Street School will also be performing their annual musical next week, which this year will be *Pirates! 2: The Hidden Treasure*.

Dr. Celano stated that we have finished the winter sports season with some wonderful accomplishments. He then proudly stated the following:

- The Wrestling Team finished second in our league and advanced to the top 8 in the Nassau County Dual Meet Championship
- The girls' bowling team finished the regular season in tenth place in Nassau County out of 40 schools, which qualifies them to compete in the Nassau County Championship tournament
- Boys Varsity Swimming and diving: Andrew Simons, grade 7 competed in the Nassau County Division Diving Meet and finished in 6th place for Division C; Seven of our swimmers will be competing at the Nassau County Meet next week for a chance to qualify for the All-County Team
- Our new Fencing team enjoyed a very competitive inaugural year. Five members of the team will be advancing to the individual Nassau County Fencing championships. Two of our students ranked #1 in Women's and Men's Nassau County Sabre Weapon.

Dr. Celano stated that tonight we are recognizing and congratulating two students who were named semi-finalists in the prestigious Regeneron Talent Search competition for their outstanding research.

VII Recognition of Outstanding Student Achievement

Ms. Guercin congratulated Herricks High School seniors, Carrie Hsu and Bhav Patel on being named Semi-Finalists in the 2020 Regeneron Science Talent Search, as announced by the Society for Science & the Public. Carrie and Bhav are recognized among the top 300 scholars for this prestigious math and science competition and will be awarded \$2,000 each. Scholars were selected from 1,993 applications received from 659 high schools across 49 states, Washington, D.C., Puerto Rico, Guam and eight countries. They were chosen based on their exceptional research skills, commitment to academics, innovative thinking and promise as scientists. Ms. Guercin then thanked Science Chair Karen Hughes, who was unable to attend tonight's meeting.

On behalf of the Board of Education and Central Administration, Dr. Celano congratulated Bhav, Carrie, their parents, Research Science Teacher Renee' Barcia, and High School Science Department Chair Karen Hughes.

B Approval of Summer Programs: Language Immersion, ENL JumpStart and Secondary ENL Writing Enrichment 2020

The Secondary ENL Writing Enrichment program is a new program. This program will focus on improving writing to ensure that our ELL's have the tools and deep understanding of the writing process in order to be successful in their academic courses. This program is funded through Title III, Part A ELL grant funds. The dates will be determined based on survey results of current and former grade 6-11 ELL students to ensure maximum participation.
